1. Conference Overview

The 2026 FSM Finance & CTA Conference brings together the National and State finance leadership of the Federated States of Micronesia, the Office of the National Public Auditor, and our development partners under a single theme: Strengthening Public Financial Management through FMIS Innovation. The five-day program opens with strategic framing and FMIS direction-setting on Day 1, moves through audit, reconciliation and stream-based breakouts on Day 3 to 4, and culminates on Day 5 with stream plenary, resolution drafting and the formal Closing Ceremony.

5. Conference Logistics & Notes

Registration

A staffed registration desk operates from 08:00 each day in the Library foyer. On Day 1 delegates receive a name badge, conference pack (programme, breakout assignment, FMIS quick-reference) and the Resolution template.

Meals

Breakout Streams

Each delegate is pre-assigned to one of four streams (Budget, CTA, Investment, Treasury). Assignments are confirmed at registration. Stream leads are responsible for capturing draft resolutions during the Day 5 breakouts and finalising them.

Resolution Process

Each stream produces a written resolution covering: (i) policy commitments, (ii) FMIS-related actions, (iii) reporting obligations. Stream resolutions are consolidated by the DOFA Secretariat on the afternoon of Day 6 to be finalized and adopted during Day 7 closing session.

Retreat

The afternoons of Day 6 and Day 7 are to be utilized as Retreat & Closing picnic for participants to enjoy the life in Kosrae (to be arranged with Director Lipar George's Office. -a visit to the Walung island or to the Lelu Ruins) while the Secretariat completes the final resolutions for the closing conference and the final picnic for closing the conference.
